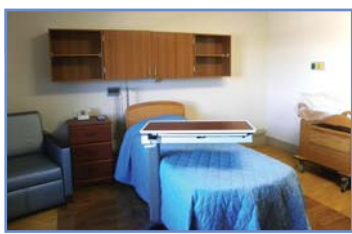

**THE HEALTHALLIANCE EMERGENCY DEPARTMENT AT THE KINGSTON HOSPITAL**

The Emergency Department is staffed by the EMA (Emergency Medical Associates) Physicians, Physicians Assistants and Nurse Practitioners. The Physicians are all Board Certified in Emergency Medicine. EMA staffs many other hospital systems in Northern New Jersey and New York State. The website for this dynamic team is: <http://www.ema-ed.com>.

The new Emergency Department boasts state of the art patient care rooms with advanced monitoring

equipment in private rooms. The rooms are designed to provide noise reduction with glass doors, direct visibility with the clinical team, centralized vital sign monitoring, and a space that is conducive to advanced medical stabilization and care.

The new Emergency Department at The Kingston Hospital will have a total capacity for 35 patients at a time. Staffing will be commensurate with the trend-monitored patient volume and peak presentation times. The

staff consists of nurses who maintain certifications in Advanced Cardiac Life Support, Pediatric Advanced Life Support, Trauma Care and Emergency Nursing. In addition, the clinical care team includes Specialty Care Technicians, Clerks and Registrars.

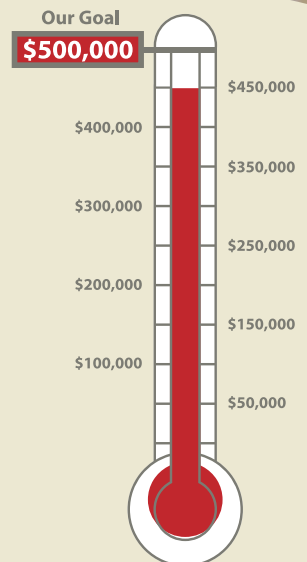

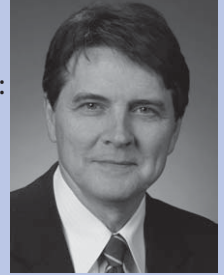
Dear Friends and Family Members,
